Bob reported that 20 people attended in person and 30 attended on the telephone. Bob asked for volunteers to host other lunch and learn programs, including one on trademark issues.

# ANNOUNCEMENTS FROM THE CHAIR AND VICE CHAIR OF THE BUSINESS

### LAW SECTION

Russ Blaine (BLS, chair-elect), Lou Conti (BLS, secretary-treasurer), and Bill Wiley (BLS Lobbyist) thanked everyone for attending. Bill Wiley indicated that this legislative session appears to have little of interest to our committee currently being considered, but he will continue to monitor new bills and advise us accordingly. Bill also reported that the voters returned good people to the legislature.

### **IP PAMPHLET**

The Chair announced that the IP pamphlet is now available and encouraged everyone to order copies.

### **COMMITTEE COMMUNICATIONS**

Steph Nagin spoke about the Business Law Journal and his efforts to elevate it and make it more practitioner friendly. Members of the committee volunteered to write articles for the Journal. The Vice Chair offered to write a case brief on Rapp v. Jews for Jesus. Steph and the committee also thanked Steve Milbrath for his contribution discussing the Broadcom case.

#### **OLD BUSINESS**

The Chair raised several projects for discussion. With respect to a revision of Chapter 815, the Chair noted there was little interest from criminal attorneys to participate in this large project. Sam Lewis volunteered to review the issue to determine if the project could be made more focused.

Doug McDonald addressed the issue of drafting a set of IP jury instructions. It was noted that both the Federal Circuit and the AIPLA have released sets of IP jury instructions. Doug and Ava agreed to discuss this project further and report back.

The Chair raised the possible project of revising the TMEP used by the Florida Secretary of State since the current set was not useful as it applied to the old Florida trademark act.

Ken Hartmann noted that the Chair's previous suggestion of a NITA/INTA trial advocacy program was a good one, but that perhaps it could be offered in an abbreviated version. Steph noted that what NITA really needs is materials for such a program to make it viable. It was suggested that if the committee were to work on this project a subcommittee would be necessary.

Finally, the Chair mentioned the necessity for updating the IP certification materials. Doug McDonald indicated that there were many patent law updates to the materials that were required.

### NEW BUSINESS

Doug McDonald gave a short presentation on the recent decision of the Federal Circuit in In re: Bilski. It was informative and well received.

Leora Hermann gave a short presentation on the recent Ninth Circuit decision in United States v. Abel Time, Inc. It was informative and well received.

The Chair noted with sorrow the passing of well renowned and respected Florida IP attorney Jack Dominick. He will be missed.

### **CLE PRESENTATION: EGYPTIAN GODDESS**

Perry Saidman of Saidman Law Group gave a presentation on the Federal Circuit's recent en banc decision on design patents Egyptian Goddess, Inc. v. Swisa, Inc., entitled Egyptian Goddess Exposed!
